THIS URBAN OASIS WAS SET ASIDE BY SAS TO CONSERVE AND ENHANCE WETLAND COMMUNITIES WHILE OFFERING ENVIRONMENTAL EDUCATION ACCESSIBLE TO ALL AGES. THE PRESERVE SERVES AS AN OUTDOOR CLASSROOM WHERE VISITORS CAN LEARN ABOUT WETLAND ECOLOGY, OBSERVE WILDLIFE, AND PARTICIPATE IN ONGOING RESEARCH AND RESTORATION EFFORTS.

IN 2024, THE PRESERVE’S BUSY BEAVER VOLUNTEER CORPS CONTINUED TO THRIVE, WITH 80 TRAINED VOLUNTEERS CONTRIBUTING TO WEEKLY CITIZEN-SCIENCE ACTIVITIES. THESE INCLUDED AVIAN POINT COUNTS, PIEZOMETER AND WELL MONITORING, VEGETATION AND WILDLIFE SURVEYS, AND OTHER PROJECTS THAT BUILD VITAL BASELINE DATA FOR LONG-TERM RESEARCH. THE YEAR ALSO SAW THE LAUNCH OF MONTANA’S FIRST-EVER WETLAND MASTER NATURALIST COURSE, A HANDS-ON EDUCATIONAL PROGRAM OFFERING PARTICIPANTS FIELD-BASED TRAINING IN WETLAND ECOLOGY AND STEWARDSHIP. INDRELAND PRESERVE LED WEEKLY BIRD WALKS, HOSTED SCHOOL GROUPS, AND OFFERED WORKSHOPS ON TOPICS SUCH AS ALTERNATIVE WEED CONTROL AND WILDLIFE MANAGEMENT. IN JULY, COMMUNITY MEMBERS JOINED SAS FOR THE THIRD ANNUAL BIOBLITZ AT THE INDRELAND PRESERVE, DOCUMENTING THE BIODIVERSITY OF THIS GROWING CONSERVATION AREA.
